An elector who is entitled to vote in an election in a municipality and believes on reasonable grounds that a registered third party who is registered in relation to the election in the municipality has contravened a provision of this Act relating to campaign finances may apply for a compliance audit of the campaign finances of the registered third party in relation to third party advertisements, even if the registered third party has not filed a financial statement under section 88.29.

Deadline for filing Application

Subsection 88.35 (3) of the Municipal Elections Act, 1996, (Act) provides that the Application must be made within 90 days after the latest of the following dates:

- 1. The filing date under section 88.30 **June 29, 2023** would be the last day to file a compliance audit request for the December 31, 2022 reporting period (regular campaign period filing deadline is 2:00 p.m. on March 31, 2023).
- 2. The date the candidate filed a financial statement, if the statement was filed within 30 days after the applicable filing date under section 88.30 **July 31, 2023** would be the last day to file a compliance audit request for the December 31, 2022 reporting period (regular campaign period late filing deadline is 2:00 p.m. on April 24, 2023).
- 3. The candidate's supplementary filing date, if any, under section 88.30 **December 28, 2023** would be the last day to file a compliance audit request for the June 29, 2023 supplementary reporting period (supplementary campaign period filing deadline is 2:00 p.m. on September 29, 2023).
- **4.** The date on which the candidate's extension, if any, under subsection 88.23 (6) expires court granted extension.
